GREETINGS FROM THE STATE DIRECTOR

150 Years of Dedication and Service to Rural America

During 2012, USDA celebrated 150 years in existence. Several events were held around the country and in Missouri to commemorate the history and work of USDA. Participating in some of these events made me reflect back on our past accomplishments - which are many. Over the years, we have had many changes take place and our employees have always been able to adapt to those changes. One thing that has never changed is our dedication to assisting people in rural Missouri improve their quality of life. Whether that is through our Single Family Housing program and providing a family with a home, or our Water and Waste program where we improve the water or sewer system in a community or

through our Business and Industry program where we help create jobs or any other examples of our 40+ programs available to assist rural life.

I recently was thinking about the programs we offer and what the public's perception is of our Agency. I know we have a lot of support from elected officials and the communities we serve. But, do we really make a difference in communities? USDA Rural Development is the only Federal Agency that is really assisting the "rural" parts of the state with almost any need they might have.

One thing that seems to surprise most people about us is the fact that we are not a "give away" Agency. This is often the perception of some people about Rural Development's programs. In fact, in Missouri, when you take our total funding for Fiscal Year 2012, grants only account for 5.5 % of the funds expended. Loan guarantees account for 61% and direct loans for 33.5%. What is also remarkable is that administratively it only costs 1.5 cents for every dollar expended for Rural Development staff to deliver our programs. I see this as a very efficient operation.

We truly do make a difference in rural Missouri and I have my staff to thank for this success. Because of them, we are able to get the funds out to those in need. We have some great examples of the assistance we have provided in this edition of the newsletter. We hope you enjoy and remember—we truly care about the communities we serve!

Fiscal Year 2012 Accomplishments

2012 HIGHLIGHTS

Statewide

- \$992 MILLION invested in support of economic development
- \$2.7 MILLION delivered each day in Missouri to improve quality of life
- 1.5 CENTS in administrative cost for every dollar distributed

Housing

- Over 5,700 households assisted with affordable housing representing
- \$586 MILLION in affordable housing assistance
- 671 Multi-Family Housing complexes administered
- 2nd largest number of complexes in the nation

Electric

Fiscal Year 2012 was another outstanding year for Missouri Rural Development. Staff continued to provide excellent service and find solutions to meet the needs of rural Missouri residents. Through program delivery, staff were able to improve the quality of life for thousands of residents and visitors.

The 2012 Highlights present the tax dollars returned and the number of beneficiaries. With these tax dollar investments, 1,514 Missouri jobs were created or retained.

On May 22, 2011, Joplin and Jasper and Newton Counties were hit by a EF5 tornado. Since that day, affected communities have been recovering, repairing, recuperating and reviving. To assist in those efforts, Rural Development (RD) provided Section 502 Guaranteed Single Family Housing and Business and Industry Guaranteed Loans. From January 2012 through October 2012, in partnership with local lenders, RD assisted 217 families with home loans in the amount of \$22,612,041. To assist with home purchases through the Single Family Housing Guaranteed Loan program, RD was able to issue a population waiver which allowed the program to be utilized despite Joplin's population exceeding the 20,000 limit. The waiver has been extended through September 2013. On October 11, 2012, Missouri State RD Director Janie Dunning and Deputy Under Secretary Doug O'Brien hosted an event on the campus of Missouri Southern State University to congratulate Joplin and Jasper and Newton Counties on the recovery efforts and to thank several community partners: Arvest Bank, Community Bank and Trust, Hometown Bank, Pioneer Warehouse, Red-wood Development, Ozark Gateway Association of Realtors and Wade and Kelsey Harper. Only through working partnerships and the dedication of businesses and organizations like these represented has Joplin and Jasper and Newton Counties been able to triumph over tragedy.

The new Andrew County Jail

Andrew County, Missouri has a new county jail facility. Janie Dunning, State Director; Doug O'Brien, Deputy Under Secretary for Rural Development; Clark Thomas, Missouri Community Programs Director; Sara Loe, State Architect; Neal Miller, Area Director and Stan Wolfe, Area Specialist attended the dedication and ribbon cutting ceremony on October 12, 2012.

The new facility will be staffed by 11 jailers and 4 dispatchers. The new jail contains 17,600 square feet and is capable of housing 63 inmates. The facility provides law enforcement services for the entire Andrew County area.

The Andrew County Public Benefit Corporation financed the project by obtaining two (2) Rural Development loans of \$5.2 million and \$700,000. Ms. Dunning stated, "Funding for the new building is another example of Rural Development being able to fill a gap and meet a need identified by a community. The facility should provide Andrew County many years of quality service."

Moberly Area Community College (MACC) held a ground-breaking ceremony in Hannibal on November 7, 2012 for the college's new Higher Education Center. The new facility is being financed in part through a Rural Development Rural Economic Development Loan (REDL) of \$1,000,000. Ralls County Electric Cooperative is the intermediary lender for MACC. The facility will contain 16,890 square feet. Current enrollment at Hannibal is 301 students. The building will include classrooms, a library and faculty and staff offices. State Director Janie Dunning attended the ceremony. Ms. Dunning stated, "Education is such an important part of creating community. Moberly Area Community College and the City of Hannibal are congratulated on their ability to see the future and take a proactive approach to meeting needs. The same can be said of the Ralls County Electric Cooperative. Thanks to everyone for being participating partners."



HISPANIC/WOMEN FARMERS/RANCHERS CLAIMS PROCESS

Attention Hispanic and Women Farmers and Ranchers

If you believe that the United States Department of Agriculture (USDA) improperly denied farm loan benefits to you between 1981 and 2000 because you are Hispanic or are female, you may be eligible to apply for compensation.




