Inter Mountain Cable, Inc. will use Rural Utilities Service funds to provide broadband services to residents, businesses, and critical community facilities within the community of McCombs, Kentucky through a Hybrid Fiber-Coax (HFC) Network. By connecting this network with their other networks, Inter Mountain Cable will provide a full range of broadband services to the residences, businesses and critical community facilities within the McCombs, Kentucky area. Inter Mountain Cable will provide broadband service free of charge to the community's fire department, and provide and staff a Community Center. The Community Center will provide residents the use of at least 10 computer workstations with broadband Internet access, operational assistance and training, and technical support free of charge for two years.

A community center will be established as part of the project where local residents can access the Internet for free and where the grantee will provide computer/internet training workshops. Free broadband Internet access will be provided to the community center and volunteer fire department for two years.

A new community center will be established, providing the residents with continuing adult education through on-line courses and a meeting place for the community's private groups and clubs. The community center and local post office will receive broadband Internet service free of charge for two years.

Crystal Broadband Networks, Inc. will use Rural Utilities Service funds to provide broadband services to the small town of Yellow Rock, Kentucky through a hybrid fiber coax network. The community is often threatened by severe weather conditions, including tornados. Real time weather radar and national weather updates are critical in saving lives. Broadband Internet access will allow the community's fire and rescue personnel the ability to receive virtual real time weather warning updates which saves lives. The community center and local schools will receive broadband Internet service free of charge for two years.

The computers available for free public use are being housed in an addition off of City Hall paid for by the grant. The Volunteer Fire Department, Part-time Police Officer, and the Mayor will all benefit from the addition of high speed Internet access.

Rural Development funds will be used to add a community center to City Hall; ensuring residents of Berry, Kentucky have free access to the Internet. The Broadband service will be deployed using DSL technology. Great community support was shown, 269/310 residents signed a petition in support of SouthEast Telephone Inc. application for the grant. The critical facilities served by the grant will include: Harrison County Fire Department, Berry Fire Department, Berry Post Office, and City Hall.

This project will establish a Community Center, located in the Health and Human Services Center providing 10 computers to be available to local citizens. In addition, the County Health Department, Adult Education/Literacy Program, Emergency Medical/Ambulance Service and the Sheriff Substation will be connected to the highspeed broadband service. Other McLean County school and government facilities will be connected through the use of fixed wireless equipment.

**New Cities Foundation Bellefonte, Kentucky**

Bellefonte, Kentucky is a small community with limited financial resources and no highspeed broadband service. The residents of the community have higher unemployment rates and lower educational levels than is the average in Kentucky. With the grant funds, the applicant will install an engineering base station and activation of wireless modems including one at the fire station/police station, one at city hall and ten at the church basement/community center located adjacent to city hall. The wireless service is available up to five miles for businesses and residences providing high-speed availability. The wireless Internet service works through the installation of a small fifteen-foot antenna placed on the local water tank.



**New Cities Foundation Raceland, Kentucky**

Raceland, Kentucky is a small community with limited financial resources and no broadband service. The community is challenged with above average unemployment rates and a large number of residents needing additional education and training. The grant will provide for an engineering base station installation and activation of wireless modems including two at schools, one at the fire station/police station, one at city hall and 24 at the Raceland Community Center located adjacent to city hall. Participating in this project will be the Campbell Elementary School, the Raceland Independent High School, the fire station/police station, and the community center.

Phelps, Kentucky is in Pike County, deep in the mountainous heartland of eastern Kentucky. Due to poverty and unemployment rates, the Appalachian Regional Commission designates the county as an "economically distressed county". Participants in this project will include the ARH Phelps Clinic, Good Shepard Nursing Home, Majestic Family Resource Center, Majestic Grade School, Phelps Ambulance Service, Phelps Area Technical Center, Phelps Army ROTC, Phelps Branch Library, Phelps Elementary and High School, Family Resource Center, Volunteer Fire Department, and the Presbyterian Health Center.
