American Recovery and Reinvestment Act

In March, Agriculture Secretary Tom Vilsack announced the U.S. Department of Agriculture (USDA) will assist in implementing \$28 billion in funding through the American Recovery and Reinvestment Act (ARRA) of 2009.

A portion of this money will be provided to USDA Rural Development to assist projects that will improve the infrastructure in rural Iowa, including water and wastewater systems, as well as essential community facilities.

Project Areas of Emphasis

The American Recovery and Reinvestment Act outlines the following project priorities:

- Construction ready
- Building projects

Sample Eligible Projects

- assisted living facilities ▪ child care centers ▪

Eligible Applicants

- Community-based non-profits ▪ Public Bodies ▪
- Federally recognized Native American Tribes ▪

Water & wastewater systems - must be located in rural areas less than 10,000 population
 Community Facilities - must be located in rural areas less than 20,000 population

*Smaller requests (less than \$200,000) and those in combination with a loan or guarantee will be given more priority. All grant determinations based on project need, priority and availability of funds. Maximum threshold established based on median household income of service area.

Application Process

Applications for ARRA funds will be processed through the local USDA Rural Development area office. Area office service areas and contact information are available on the Rural Development web site.

The application process for these new funds will remain basically the same as our normal funding and will include an extensive review process including concurrence by the Secretary of Agriculture. Application materials are available on the Rural Development web site.

Projects being considered for ARRA funds must meet several special criteria. **First**, the Recovery Act requires the Davis-Bacon Act be followed.

Second, the Recovery Act requires that all projects receiving funding meet the Buy America criteria.

Lastly, the Recovery Act requires each recipient to agree to certain reporting criteria and certifications to assure transparency and appropriate use of taxpayer dollars.

USDA Rural Development is looking for new applications. Now is the time to review and complete project applications so funds can be requested. Projects receiving ARRA assistance must be ready to start quickly after receiving funds. ARRA funds will not be available after September 30, 2010.

If you have an application on hand with USDA Rural Development, please contact your local area office to determine its status and materials needed to complete your application. All projects are subject to an environmental review.
