USDA RURAL DEVELOPMENT RECOGNIZES 30th ANNIVERSARY OF GLENWOOD HOUSING CORP.

Senior Living Apartment Complex Completed in 1978

GLENWOOD, IOWA – May 14, 2009 – Kimberly Clay with USDA Rural Development today presented a plaque to Glenwood Housing Corp. recognizing the non-profit corporation's 30 years of providing housing services to elderly and disabled residents in the Glenwood area.

“Ensuring that elderly and disabled Iowans living in rural communities have decent, safe and affordable housing has been a top priority of USDA Rural Development for many years,” said Timothy Helmbrecht, USDA Rural Development Acting State Director. “It’s through housing projects like this one that we are able to help as many rural Iowans as possible have access to adequate housing during their retirement years.”

Glenwood Housing Corp. consists of 30 one-bedroom apartments. In March of 1978 the complex was completed. The complex is located at 108 11th Street, Glenwood.

The first board of directors included David L. Snow- President, Darrell E. Mayberry- Vice-President, Robert Palmquist- Secretary, and Clarence Boles, Jr.-Treasurer. There was an original membership of 153. The property is managed by Ron Smouse, Smouse Financial Services, Inc. of Springfield, MO. USDA Rural Development currently provides financing for nearly 550 multi-family housing projects located in 370 communities in rural Iowa. These projects provide rural Iowans with access to more than 10,000 apartments. Rent in the apartments is based on income, and rental assistance from the government is available depending on the income of the tenant.

Apartment complexes play an important role in the sustainability of rural communities. They allow residents to continue to live in their home community, many times close to family and friends. Apartments also offer numerous opportunities for social activities with friends and others in the same age group and with the same interests, as well as provide a great opportunity for young adults to build up equity so they can some day become homeowners.

Each year USDA Rural Development invests around \$100 million in loans and grants that provide rural residents with decent, safe and sanitary single or multi-family housing. Housing loans can be obtained directly with Rural Development or from a private financial institution.
