PURPOSE:

- ◆ Reduce or eliminate pollution of water resources.
- ◆ Improve planning and management of solid waste sites.

ELIGIBLE APPLICANTS:

- ◆ Private non-profit organizations that have been granted tax exempt status by the IRS.
- ◆ Public bodies, including local government-based multi-jurisdictional organizations.
- ◆ Federally recognized Indian tribes .

ELIGIBILITY REQUIREMENTS:

- ◆ Applicant must have the proven ability, background, experience, legal authority and actual capacity to provide technical assistance and/or training on a regional basis in towns and cities of less than 10,000.

ELIGIBLE PURPOSES:

- ◆ Evaluate current landfill conditions to determine threats to water resources.
- ◆ Provide technical assistance and/or training to enhance operator skills in the safety, maintenance and operation of active landfills.
- ◆ Provide technical assistance and/or training to help communities reduce the solid waste stream.
- ◆ Provide technical assistance and/or training for operators of landfills which are closed or will be closed in the near future with the development and implementation of the plans for closing \ and future land use.

INELIGIBLE PURPOSES:

- ◆ Recruit applications for USDA, Rural Development water and waste disposal programs.
- ◆ Duplicate current services, replacement or substitution of support previously provided.
- ◆ Fund political activities.
- ◆ Pay for capital assets, the purchase of real estate or vehicles, improve office space, or repair and maintain privately-owned property.
- ◆ Pay for construction or operation and maintenance costs.
- ◆ Pay for costs incurred prior to the effective date of grant approval.
- ◆ Pay for technical assistance which duplicates assistance provided to implement an action plan funded by the Forest Service.

PREAPPLICATIONS:

- ◆ Interested entities may submit a preapplication using Form SF 424.1, "Application for Federal Assistance (non-construction) between October 1 and December 31, to the Idaho State Office or the USDA, Rural Development National Office in Washington, D.C.
