The afternoon session will be held from 1:00 PM – 3:30 PM with Rural Development covering lease completion as well as a Q & A session. Lunch will be provided at each location from 12 PM – 1:00 PM. Registration will begin at 8:00. *The registration fee will NOT be prorated if you are only attending one session (AM or PM).*
