

TENNESSEE SUPPLEMENT TO 1940-G



This Supplement has been developed to provide Rural Development Program Specialists in Tennessee with names and addresses of Federal and State agencies to contact for information to be included in environmental reports for housing, business, and community facility projects to be funded through Rural Development or with funding guaranteed by Rural Development.

Program Specialists should inform the applicant that during the period of application review and processing, the applicant should take no action or incur any obligation with respect to their proposed undertaking which would have any impact on the environment or limit the range of environmental alternatives for the project. The completion of the environmental review must occur prior to the issuance of the letter of conditions.

RD Program Specialists should advise applicants as to the environmental soundness of their proposed project early in the planning process to facilitate the analysis of alternatives. Rural Development Program Specialists may obtain technical assistance to prepare the environmental review from the following:

1. Historical and Archaeological Sites:

Tennessee's State Historic Preservation Officer (SHPO) must be contacted on all environmental assessments except those, which have been categorically excluded. The address, phone number and web site are listed below:

2. Wild and Scenic Rivers:

The Nationwide Rivers Inventory list must be checked to determine if the property is adjacent to, contains, will discharge, or withdraw water from one of the rivers or creeks listed. The U.S. Forest Service must be contacted if a project is near an inventory river in one of the National forests. The National Park Service must be contacted in other areas.

5. Wetlands:

If construction will occur in a wetland area, the U.S. Army Corps of Engineers (COE) must be contacted to determine the need for a 404 permit. A 404 permit is an absolute must when fill activities occur in a wetland. The address for COE is:
