SUBJECT: Fiscal Year 2004 State Internal Review Process

PURPOSE/INTENDED OUTCOME: This Administrative Notice (AN) is issued to establish the Fiscal Year (FY) 2004 State Internal Review (SIR) schedule and revise the five year plan.

COMPARISON WITH PREVIOUS AN: This AN replaces AN 570 which expires September 30, 2003.

IMPLEMENTATION RESPONSIBILITIES: The Management Control Officer (MCO) in Texas is Donna Freytag. The MCO is the team coordinator for all SIRs.
