USDA RURAL DEVELOPMENT AWARDS \$500,000 FOR THE DISTANCE LEARNING AND TELEMEDICINE PROGRAM

Temple, Texas, September 30, 2003—Bryan Daniel, State Director, for Texas USDA Rural Development today announced the selection of Region XI Education Service Center as a recipient of the Distance Learning and Telemedicine (DLT) Grant program.

Region XI located in Fort Worth, Texas, covers a 10 county area (Cooke, Denton, Tarrant, Johnson, Somervell, Hood, Erath, Palo Pinto, Parker, and Wise) and serves 78 school districts with over 400,000 students and 31,000 educators. Region XI will use the DLT funds to purchase videoconferencing systems for 8 school districts, and help 24 other districts that already have videoconferencing systems receive free content and services to be used for instructional purposes in the classrooms.

“Everyone who has played a role in extending telecommunications service to rural Texans should be very proud of what has been accomplished,” said Bryan Daniel, State Director. “The communication lines you help build and maintain are truly the life lines of the nation’s rural heartland.”

In total, 57 distance education grants for \$23.5 million, and 27 telemedicine grants for more than \$8.9 million were selected for funding. The education projects will help 556 schools provide students with educational tools to better equip them for the global digital economy. Additionally, rural residents will have access to better, faster, and more modern health care through 190 medical service facilities.
