USDA RURAL DEVELOPMENT AWARDS \$500,000 FOR THE DISTANCE LEARNING AND TELEMEDICINE PROGRAM

Temple, Texas, January 22, 2004—Bryan Daniel, State Director, for Texas USDA Rural Development today announced the selection of Coastal Bend College as a recipient of the Distance Learning and Telemedicine (DLT) Grant program.

The DLT funds will be used to assist Coastal Bend College in better serving the needs of its diverse, economically disadvantaged, rural population residing in a twelve county area. Most students from this large service area have only limited exposure to technology. Coastal Bend College will expand its distance learning program by equipping state of the art business technology classrooms on its campus locations in Alice, Beeville, Kingsville, and Pleasanton and the campuses of its high school partners Orange Grove ISD, Pettus ISD, Premont ISD, and Skidmore-Tynan ISD.

“Everyone who has played a role in extending telecommunications service to rural Texans should be very proud of what has been accomplished,” said Bryan Daniel, State Director. “The communication lines you help build and maintain are truly the life lines of the nation’s rural heartland.”

In total, 57 distance education grants for \$23.5 million, and 27 telemedicine grants for more than \$8.9 million were selected for funding. The education projects will help 556 schools provide students with educational tools to better equip them for the global digital economy. Additionally, rural residents will have access to better, faster, and more modern health care through 190 medical service facilities.
