## **USDA RURAL DEVELOPMENT ANNOUNCES FUNDING FOR ROBECO, INC.**

**LEVELLAND, TEXAS**, June 28, 2004 – USDA Rural Development, State Director, Bryan Daniel, announced today that Robeco, Inc., received a \$461,400 Business and Industry Guaranteed loan. USDA Rural Development is charged with assisting rural communities by administering programs targeted to strengthening the economy and infrastructure of rural areas.

“We are pleased to fund this project in Levelland,” said Daniel. “One of our goals is to provide access to credit for rural businesses that will bring new jobs to the area for local residents.
