USDA RURAL DEVELOPMENT ANNOUNCES FUNDING FOR ELM CREEK WATER SUPPLY CORPORATION

MOODY, TEXAS, August 13, 2004 – USDA Rural Development, State Director, Bryan Daniel, announced today that the Elm Creek Water Supply Corporation, received a \$765,000 Water and Waste Disposal Direct loan through the agency's Community Programs Water and Waste Disposal Loan fund. The effort is part of the USDA's national program to help provide rural areas with safe, dependable water and modern sewage systems.

"One of the goals of USDA Rural Development is to provide water and wastewater treatment programs that target public health benefits and provide economic opportunities to America's rural communities," said Daniel. "Rural residents can utilize our programs to help provide essential public services that will enhance their quality of life."

The loan funds for the Elm Creek Water Supply Corporation will be used to construct new facilities at the existing Plant No. 2 which will employ a new Gallons Per Minute well, yard piping, compressor fitting and connections. Approximately 1,175 users will be served by this project.

In Fiscal Year 2003, \$64.4 million of loan and grant assistance was infused into 71 projects and assisted 137,451 rural Texans. USDA Rural Development's water and wastewater program is designed to bring fresh, clean drinking water and sanitary, environmentally sound sewage facilities to rural America's 53 million residents. Loans and grants are available to rural communities with fewer than 10,000 residents. Public bodies, corporations operated on a nonprofit basis, and Indian tribes, that are unable to obtain credit from other sources at reasonable rates and terms, are eligible for assistance.
